## **FOCUS ON SAFETY – Housekeeping**

To some people, the word "housekeeping" calls to mind cleaning floors and surfaces, removing dust, and organizing clutter. But in a work setting, it means much more. Housekeeping is crucial to safe workplaces.

The practice extends from traditional offices to industrial workplaces, including factories, warehouses and manufacturing plants that present special challenges such as hazardous materials, combustible dust and other flammables. Experts agree that all workplace safety programs should incorporate housekeeping, and every worker should play a part. Here are some tips for effective workplace housekeeping:

- Keep aisles, walkways, and exits clear of tripping hazards
- Clean up spills and treat slippery conditions immediately
- Properly store combustible materials and keep flammable Materials away from ignition sources
- Clear clutter by removing debris and putting tools away after use.

While OSHA regulations require that each working surface be cleared of debris, including solid and liquid waste, at the end of each work shift or job, whichever occurs first, to fully realize the benefit of a clean workplace, it is often easier to maintain good housekeeping throughout the course of the job and workday.

Remember that dry sweeping is prohibited on construction sites and many industrial and commercial sites per the Respirable Crystalline Silica Regulations; Sweeping compound, wet sweeping or HEPA vacuums must be used!
